5.	COUNTY COUNCIL AFFAIRS: Cllr Topping attended the meeting and verbally gave a report. A) CLEARANCE OF CCC LAND NEAR SCHOOL CAR PARK Cllr Topping suggested a meeting date which unfortunately the PC couldn't make, so a new date needs suggesting. Cllr Roberts and Cllr Wragg to provide the Clerk/Peter Topping with some dates. SCDC Footpaths Officer to come out to the same meeting. Cllr Wragg thanked Cllr Topping for his help behind the scenes regarding the successful LHI Funding bid, where Fowlmere came out top in the County. Clerk to respond back to accept the offer, and press them for a date. Clerk to check whether Fowlmere School is affected by the funding issues and needs support with this? Clerk to ask the Head/Chair of Governors. Re resurfacing of footpaths – CCC Whittlesford can be approached if needed - Clerk to be made aware of any sites requiring resurfacing. 6.	DISTRICT COUNCIL UPDATE: The Planning Dept at SCDC is causing concern. Manor Farm and Chapel Lane planning applications have been approved (the latter on delegated powers) despite material reasons advanced by FPC for the Planning Committee to view the sites and take the decision on the applications. The Chapel Lane application is very large and close to the existing properties, SCDC have not admitted any inconsistencies (also there was a full month from the decision being taken to the paperwork being sent out, with no time for any immediate objections). The neighbours are to meet with Cllr Roberts and Cllr Wragg soon to take this forward. The applicant appears to be breaching conditions by working too close to the fence and undermining it. The SCDC Planning Dept is being badly led by the Chairman of the Committee. The officers who were experienced have left and the remaining officers are inexperienced/new or on contracts and they seem to be out of their depth. Julie Baird has also handed her notice in. The Chairman of the	

	<p>Planning Committee should be invited to Fowlmere to address some of these issues (David Bard). Cllr Howe – should Heidi Allen be made aware? Cllr Wragg and Cllr Roberts to draft a letter.</p> <p>Cllr Roberts informed Cllr Topping that she has no confidence in the way the Planning Dept at SCDC is being led.</p> <p>Cllr Topping, whilst being Leader of the District Council attends Parish Meetings as the County Councillor. He explained that Stephen Kelly is reorganising the Planning Department at SCDC, encouraging officers to work in a better way. It is a disappointment that Julie Baird is leaving but an interim manager has been appointed. He has been impressed by the ‘younger’ planning officers. Large sites will be closely monitored now by SCDC, to take a more proactive role in working with them.</p> <p>Cllr Vinton said that, since becoming a Parish Councillor, he has seen a lot of interest and dedication from the Parish Council in the work they do assessing planning applications, with the best interests of Fowlmere at heart and yet has seen them over-ruled and ignored time and again by officers or the Planning Committee at SCDC.</p> <p>Mr Mulholland fully explained the situation with the history of the application in Chapel Lane.</p> <p>Cllr Topping to set up a meeting with Julie Baird and he will contact Charlie Swain from Enforcement too. 	<p>21 Pipers Close, Fowlmere, SG8 7RX Kevin Marlow</p> <p>Cllr Bearpark mentioned that he had been approached by someone who has said there were already a lot of sheds on that property and has concerned over more noise.</p> <p>It is adjacent to the green belt and is disproportionate of size. There are questions over access. The PC does not have enough information to determine whether it is intended for commercial use and there must be questions of the access and the amount of usage. There are issues over noise, pollution and the effect on neighbouring property and we are minded to ask for a refusal. 10.	<p>ROAD SAFETY A) SPEEDWATCH / CCC BID</p> <p>Cllr Howe/the Clerk has written something for the FATN. Training has finished and we are waiting for approval on the monitoring sites that were identified when PC Jenkins met Cllrs in the village. Cllr Howe to ask why this is taking so long.</p> <p>The bid will be followed up (£3825 from CCC plus £675 from FPC), which is £1000 short of the cost of the ANPR device. The question was asked whether FPC wished to explore the possibility of seeking consent to use the funds to purchase an ANPR camera, but it was thought better to stick with what we had been awarded.</p> <p>The Cambridgeshire Police and Crime Commissioner will be speaking to Foxton Breakfast Club in April, having refused earlier to meet the Parish Council. It is regrettable that he is not giving priority to meeting statutory bodies who are responsible for the safety of their residents. FPC to extend the invitation again.
